1	USPPI Name and Address	Enter the name and address of the U.S. Principal Party in Interest (USPPI). The USPPI is the party in the U.S. who receives the primary benefit from the export transaction. Generally, this is the U.S. seller or manufacturer.
2	USPPI EIN	Enter the USPPI's 9-digit IRS Employer Identification Number (EIN). If an EIN is not available, one may be obtained from the IRS at no cost by accessing <a href="https://www.irs.gov/">https://www.irs.gov/</a> or 1-800-829-4933.
3	State of Origin	Enter the state from which the goods began their journey to the U.S. port of export. For goods originating from multiple locations, enter the state from which the goods of greatest value originated. If this is unknown, enter the state where the goods will be consolidated.
4	USPPI Contact Name and Telephone Number	Enter the complete first and last name and telephone number of the person with the most knowledge of the export shipment and related controls of the goods.
5	Foreign Intermediate Consignee Name and Address	Enter the name and address of the party in a foreign country who makes or facilitates delivery of the goods to the ultimate consignee.
6	Ultimate Consignee Name and Address	Enter the name and address of the foreign party who will ultimately receive the goods. For overland shipments to Mexico, include the Mexican state.
7	Ultimate Consignee Contact Name and Telephone Number	Enter the complete first and last name and telephone number of the person who will ultimately be receiving the goods.
8	Country of Ultimate Destination	Enter the country of ultimate destination of the party who will ultimately receive the goods, as known at the time of export.
9	Freight Location Address	Enter the address where the goods will begin the journey to the U.S. port of export, even if the USPPI does not own or lease the facility. For goods originating from multiple locations enter the address of the goods with the greatest value or the address where the consolidation will take place.
10	Related Party Indicator	Check the appropriate box to indicate related or non-related. Parties are considered related when either the USPPI or ultimate consignee own (directly or indirectly) 10% or more of the other party.
11	Foreign Routed Transaction	Check the appropriate box to indicate if the transaction is routed by a foreign party. Foreign Routed Transactions are those in which the Foreign Principle Party in Interest (FPPI) authorizes a U.S. agent to facilitate export of goods from the U.S. on its behalf, prepare and file the EEI in the AES.
12	Insurance	Check the appropriate box to indicate if the shipment is to be insured by C.H. Robinson.
13	Ultimate Consignee Type	<ul> <li>Check the primary business function of the ultimate consignee. If more than one applies, check the type which most often applies.</li> <li>Direct Consumer – A non-government entity which will use the goods for its own internal manufacturing processes or as an input to the production of another product.</li> <li>Government Entity – An agency, institution, enterprise or company owned or controlled by a government.</li> <li>Reseller – A non-government reseller, retailer, wholesaler, distributor, distribution center or trading company which will resell or distribute the goods.</li> <li>Other or Unknown – An entity which does not fit any of the above descriptions.</li> </ul>
